**Details:** State funds are to be used to promote digital equity and inclusion and to ensure that all people and communities have the skills, technology, and capacity needed to reap the full benefits of a digital economy. Focus areas include: 1) Access to and affordability of high-speed internet. 2) Accessibility and inclusivity of online public resources. 3) Digital literacy. 4) Cybersecurity and privacy. 5) Availability and affordability of devices and technical support.

**Note**: Libraries are considered Community Anchor Institutions (including a State or Territory library agency) and play a key role in implementing digital equity and building capacity across your state. Libraries may be eligible to receive subgrants from the State to carry out the state's digital equity plan. And/Or, libraries may partner with Community Based Organizations to host outreach opportunities with community members, serve as a meeting place for digital navigation opportunities to educate community members on digital literacy and safe online practices, etc.
